BE IT RESOLVED, Whereas it is necessary to update the 2020 Fee Schedule to clarify the fees and deposits that are now required by the Village, the following changes are hereby made to the 2020 Fee Schedule:

Under Cell Towers, the term "Major Modification" is hereby amended to "New Facility/Major Modification." Under Minor and New Facility/Major Modification, "\$2,500 Nonrefundable" is changed to "\$2,500 Nonrefundable application fee."

There is hereby added a new category entitled "Special Exception Applications." In that category, the following fees will be charged: For a residential Special Exception Application, a nonrefundable application fee of \$100, and a deposit of \$800. For a Commercial/Non-Residential Special Exception Application, a nonrefundable application fee of \$100, and a deposit of \$5,500.
